

### **MAZIAK EXTERNAL PRIVACY NOTICE**

This privacy notice sets out how Maziak uses and protects any personal information that you give to us. It does not apply to information we hold about companies and other organisations.

This notice covers what we collect and why, how we collect, what we do with the information, what we won't do with the information and what rights you have.

Maziak is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified, you can be assured that it will only be used in accordance with this privacy notice.

Maziak may change this notice from time to time, by publishing the amended version on our website with a banner highlighting the new version. You should check the privacy notice page on the website from time to time to ensure that you are happy with any changes. This notice is effective from 1<sup>st</sup> May 2018.

#### Who we are

Maziak provides engineering services for the compressed air and nitrogen industries and is a distributor of compressed air and nitrogen equipment within the UK. For the purposes of the General Data Protection Regulations, Maziak is a data controller in respect of the personal information that we collect and process about you as described in this privacy notice.

#### What we collect

We will only ever collect the information we need – including data that will be useful to help improve our services. We may collect and process the following data about you:

- name
- postal address (company)
- email address (company)
- telephone number (company)

When you visit the Maziak website, cookies enable us to distinguish you from other users of our site. This is statistical data and does not identify any individual - for more details see the website section below.

#### How we collect

This information is collected from you in a variety of ways, including by telephone, when meeting our sales personnel, at trade shows and via our website enquiry form.

## What we do with the information we gather

We require this information to understand your needs and to provide you with a new or better service. In GDPR terms, we are processing your data for our legitimate interests or for the performance of a contract. "Legitimate interests", means the interests of Maziak in conducting and managing our business and providing you with the best services and products in the most secure way.

"For the performance of a contract" means to fulfil Maziak's contractual obligations to you; or because you have asked Maziak to do something before entering into a contract.

#### Reasons might include:

- To respond to your queries
- To provide you with a quote
- To provide you with a service or a product
- To manage your account with us
- For general administration purposes
- To provide you with information about our products, services, offers or technical developments that you request from Maziak or which we feel may be commercially of interest you.

When we process your personal data as outlined above, we always ensure that we consider and balance any potential impact on you and your rights under data protection laws.

If you have any concerns about the processing described above, you have the right to object to this processing. For more information about your rights, please see "Your rights" section below.



## **Sharing your information**

We may share your information for any of the purposes set out above with any staff within Maziak and/or carefully chosen business partners who provide products and services to enable Maziak to fulfill our business obligations.

We may also disclose your personal information to third parties, if Maziak is under a duty to do so for legal or regulatory purposes, in relation to existing or future legal proceedings, for the prevention of fraud/loss or to protect the rights, property and safety of Maziak, its customers or others.

### **Data Security**

Maziak is committed to ensuring that your information is secure. We are Cyber Essentials accredited and have security protocols and policies in place to manage and record your data privacy and preferences correctly and ensure that your data is stored securely to protect against its loss, misuse and alteration. Maziak also takes steps to ensure that any businesses we share your data with will have similar security protocols and policies in place.

We will keep your information only for as long as is needed to provide you with the goods, services or information you have required, to administer your relationship with Maziak, to comply with the law or to ensure Maziak does not communicate with people that have asked us not to. When Maziak no longer needs information, it will be disposed of securely.

#### The website

#### How we use cookies

You can choose to accept or decline cookies. A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used on our website. This helps us analyse data about web page traffic and improve our website to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

### Links to other websites

Our website may contain links to other websites of interest. However, once you have used these links to leave our site, you should note that we do not have any control over that other website. Therefore, we cannot be responsible for the protection and privacy of any information which you provide whilst visiting such sites and such sites are not governed by this privacy notice. You should exercise caution and look at the privacy notice applicable to the website in question.

### **Controlling your personal information**

# Your rights
